## – RULES –

The following rules for the tournament will be used. These rules will be interpreted solely by the Tournament Committee and all decisions are final.

1. **TOURNAMENT COMMITTEE:** The committee will consist of at least five (5) members of the HBA of Springfield.
2. **ELIGIBILITY:** Players must be HBA members, prospective members guests, employees or family (18 years of age or older) who have paid the appropriate entry fee. Tournament Committee reserves the right to approve/deny participation by anyone else. Guests must be accompanied by an HBA member. This tournament is intended for fun and camaraderie among participating members of the Home Builders Association.
3. **ENTRY FEE:** \$85 per individual. Entries will be accepted until May 2, 2013, providing there is space available. Participants **MUST** register prior to the tournament. **REGISTRATIONS WILL NOT BE TAKEN AT THE TOURNAMENT.**
4. **TEE BOXES:** Gentlemen play from the White Tees. Ladies play from Red Tees.
5. **HOLE IN ONE HOLE (ALL PAR 3'S):** All hit from tees designated for men and women.
6. **MULLIGANS:** Mulligan will be available for purchase during sign-in. Mulligans will cost \$5 for 2. No individual may purchase more than 2 mulligans..
7. **PRACTICE SHOTS:** There will be no practice allowed during play of a hole. If you hit a practice shot after teeing off on a hole, see rule #6.
8. **PUTTING:** Use the 2 putt rule once on the green.
9. **LIE:** Play the ball up everywhere but in a water hazard. You may improve lie one (1) club length, no closer to hole. Do not change the cut of grass or improve position (do not move from behind obstacle. If behind tree, etc, one (1) club length straight back, keeping tree between you and pin).
10. **LONG DRIVE HOLES:** There will be 3 long drive holes for ages 49 & under, 2 long drive holes for ages 50-59, 2 long drive holes for ages 60 & over and 1 long drive hole for the ladies for the entire day.
12. **LONG DRIVE & CLOSEST TO THE PIN PAYOUT:** Players can only win one of the 12 long drive/closest to the pin prizes. Winners will be determined from the lowest hole to the highest number hole.
13. **PAYOUT:** Course will determine flights and winners. Ties will be determined by modified paying system. Results and cash prizes will be available at the HBA office May 7, 2013.
14. **LEGAL:** Player agrees that venue of any litigation shall be in the Circuit Court of Greene County, Missouri. Player waives his or her right to a trial by jury of any cause of action connected with the golf tournament. Player agrees that the laws of the State of Missouri shall control any dispute with the Home Builders Association of Greater Springfield. Player agrees that this agreement is binding upon the heirs, successors, and assigns of the respective parties.
15. **ON COURSE BEVERAGES:** Water, soda and sports drinks will be served to golfers at no charge. Beverages containing alcohol may be purchased from the golf course. **THERE WILL BE NO FREE ALCOHOLIC BEVERAGES.**
